Minutes of the Extra-ordinary Meeting of East Haddon Parish Council

held on Monday 6th June 2022, at East Haddon Village Hall, East Haddon at 7.00 pm.

Public Forum:

Public in attendance to raise concerns with the application to extend the licence of The Red Lion Hotel, East Haddon. Concerns raised regarding the amount of people that could be attending events and insufficient parking within the village. Cllr Bignell advised there are four reasons to object to premises licences. Residents are concerned about possible noise levels and that the conditions of such a licence are inappropriate for a pub in a village setting. One resident in attendance did not have any objections.

2022.22 LICENCE APPLICATION

Application for a premises licence to be granted under the Licensing Act 2003: The Red Lion Hotel, East Haddon. Main Street, East Haddon, Northamptonshire, NN6 8BU. Application has been submitted to extend the opening hours and the entertainment licence. Residents have raised concerns with these proposals and asked the PC to consider making representations on this application. Closing date of representations is **17th June 2022**.

Council considered the above application and **RESOLVED** to contact WNC to object to the application. The Council are objecting on the grounds of noise levels which may cause a public nuisance and inadequate parking. The Council are concerned that this is a generic licence application that covers all premises in the group, and it is not appropriate for a village pub. The Council would like a specific one for the Red Lion to be considered that would reflect the rural nature of the pubs location and have more suitable conditions.
